

**THORNTON'S SPLATTERHAUS PAINTBALL**  
**Rules & Waiver**

1. I will abide by all decisions of the referees and management of Thorntons's.
2. I will stay within the playing field boundaries at all times while I am playing paintball.
3. I will not climb trees, climb in the rafters of the fort or take part in any dangerous activities while playing paintball.
4. Should I see or believe another player might be injured; I will immediately stop the game and assist that player.
5. I am playing this game for fun and will refrain from foul or abusive language and will not engage in any arguments or physical contact of any kind.
6. I will make myself familiar with local emergency phone numbers and with any safety or first aid equipment available in case of an accident.
7. I will follow all special instructions which the game referee or field operator gives prior to each game.
8. I agree to abide by all applicable federal, state, and local laws governing the playing of this sport.
9. I will read and obey all posted signs regarding goggles and barrel plugs.
10. Every time I play, I will wear approved goggles at all times within the playing, chronograph, and target areas.
11. I understand that I will be ejected from the game for removal of my goggles within the playing, chronograph, or target areas.
12. I will only use paintball equipment approved by the APL and the field operator or sponsor.
13. I will not discharge paintballs in or onto non-designated area or adjoining property.
14. I will respect, be responsible and return all the equipment rented to me.

**THIS IS A RELEASE OF LIABILITY - READ BEFORE SIGNING**

IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball under the auspices of THORNTON'S SPLATTERHAUS PAINTBALL, I acknowledge, appreciate, and agree that:

1. The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist;
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability below, and assume full responsibility for my participation; and,
3. I understand that the activities of paintball are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THORNTON'S SPLATTERHAUS PAINTBALL the owners and lessors of premises used to conduct the paintball activities, their officers, officials, agents and/or employees ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the result of gross negligence and/or wanton misconduct.
5. I understand and agree that this Release of Liability Agreement covers each and every paintball activity and event in which I participate hereafter.
